2015 NEACHMM Scholarship Guidelines

Every year **NEACHMM** will award at least one \$1,000 scholarship in each of two categories. The goal of the scholarship program is to promote the Environmental Health & Safety (EH&S) disciplines, and to benefit our membership.

Category 1: At least one qualifying student pursuing a curriculum that leads to a career in EH&S and;

Category 2: One qualifying student related to or acquainted with a current NEACHMM member in good standing that is pursuing a degree in any field of study.

Scholarship recipients from the previous year are not eligible in consecutive years. All prospective applicants must provide a copy of registration for the upcoming semester; (letter of acceptance for in-coming freshman; scholarship awarded upon verification of registration).

Category 1; Eligible applicants are those who are, or will be **pursuing a major in a discipline of EH&S** (e.g., biology, chemistry, environmental science/engineering, health & safety management) at an accredited university, college, junior college or trade school.

Category 2;

First consideration; Immediate family member, (child, spouse), of a NEACHMM member in good standing who are **pursuing a college education** at an accredited university, college, junior college, trade school or nursing school with **no restrictions on the course of study**.

Second consideration; will be given to **NEACHMM members' grandchildren**, **nieces**, **nephews or other family members** attending an accredited university, college, junior college, trade school or nursing school with no restrictions on the course of study.

Third consideration; will be given to a **friend or acquaintance** of a current NEACHMM member in good standing attending an accredited university, college, junior college, trade school or nursing school with no restrictions on the course of study. Applicant must receive written sponsorship from the NEACHMM member to be considered.

Completed applications and required documentation must be submitted by the date indicated on the application form.

Winning recipients will be notified by the end of July with scholarships awarded by mid-August. Public recognition of scholarship recipients will be at the dinner of the annual NEACHMM golf outing / scholarship fund raiser in September, and / or at an upcoming NEACHMM meeting.
